LICENSES AND REGISTRATIONS

capitaluxltd.is committed to working closely and collaboratively with regulators from around the world. capitaluxltd. currently holds the following regulatory licenses, registrations, authorizations and approvals:

Europe

France (HEADQUARTERS)

Our France SAS has been granted registration as a Digital Asset Service Provider (DASP) by the Autorité des Marchés Financiers (AMF) (registration number E2022-037). capitaluxltd. France SAS can provide the following regulated services in France: digital assets custody ; purchase/sale of digital assets for legal tender; exchange of digital assets for other digital assets; and operation of a trading platform for digital assets.

Italy
